“Junior Creative Board” Competition – Terms & Conditions

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The “Junior Creative Board” Contest ends 11:59 p.m. EST on 31st August (“Contest Period”). Contest is sponsored by LEGOLAND Discovery Centre Manchester (“Sponsor” or “Prize Provider”).

ELIGIBILITY: The “Junior Creative Board” Competition is open to all legal residents of the United Kingdom between the ages of 5 and 10 with the permission and guidance of a legal parent or guardian. Employees, officers and representatives of the Sponsor, their parents, affiliates, subsidiaries, agents, advertising and promotion agencies, (collectively, “Released Parties”) and members of the immediate family (mother, father, sons, daughters and spouse, regardless of where they reside) and household members of each, whether or not related, are not eligible to participate in the Contest. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules.

HOW TO ENTER: Eligible participants can enter the Contest in one of the ways listed on the webpage:

By participating in this Contest, entrants agree to be bound by these Official Rules and agree that the decisions of the Sponsor are final and binding in all matters relating to the Contest. By participating in the Contest, entrants also agree that any personally identifiable information collected by the Sponsor during an entrant's participation in the Contest may be used by Sponsor, its respective affiliates, agents and marketers for purposes of the proper administration and fulfillment of the Contest as described in these Official Rules.

SUBMISSION GUIDELINES: Each entrant represents and warrants that Submission does not infringe any other person's or entity's rights. Submission must not contain any unauthorized third-party owned material, including, but not limited to, trademarks or logos, except for those of the Sponsor.

Sponsor specifically reserves all its rights to protect its intellectual property against any infringement or other illegal or improper use. Entrant also warrants and represents that he or she consents to the Submission and use of the Submission in the Contest, and to the Sponsor and Prize Provider using the Submission and posting on its Internet sites in connection with the Contest. All entries should adhere to the Facebook Guidelines and Terms of Service that are posted on Facebook's website, www.Facebook.com; the Instagram Guidelines and Terms of Service posted on Instagram's website, www.Instagram.com; and/or the Twitter Guidelines and Terms of Service that are posted on Twitter's website, www.Twitter.com. The Sponsor, in its sole discretion, may remove a Submission and disqualify any entrant from the Contest if it believes that the Submission fails to conform to the Submission Guidelines contained in these Official Rules. Submissions may not contain any of the following: i) materials which contain language inappropriate for a general audience; ii) materials which are derogatory to Sponsor, or any affiliated entity or person; or iii) materials which do not comport with the Submission Guidelines. Entries which do not conform to these Submission Guidelines will be disqualified.

JUDGING: At the end of the Contest Period a panel of judges will review all the Submissions and choose ten (10) winners. In the event of a tie, the score for Creativity will determine the final winners.

PRIZES: The winners will receive the honour of being a member of Junior Creative Board and one (1) family Annual Pass to LEGOLAND Discovery Centre Manchester Annual Passes. Winner must be willing to attend media events in

which they will be recorded on camera. Winner is solely responsible for any additional expenses not expressly stated in the Prize description above including air and ground transportation, sales tax, airport fees, lodging, service charges, tips, and any other personal charges, including but not limited to incidental travel costs due to claiming of Prize. Winner is also solely responsible for any additional expenses resulting from the winner reserving any higher priced package or any fee applied as a result of a change in the reservation, etc.

PRIZE VERIFICATION & CONDITIONS: All taxes are solely the responsibility of winner. No substitution or transfer of prize or election of cash in lieu of Prize will be permitted.
